



2 Days Enhanced Bunkering Course **(SS600:2014 & TR48:2015)**

Approved by Maritime and Port Authority of Singapore

Background

SPRING Singapore and the Maritime and Port Authority of Singapore (MPA) have implemented the Singapore Standard SS600:2014 & TR48:2015 to further enhance consistency in practices in the delivery of bunkers for ships calling at Singapore's port.

SS600:2014 & TR48:2015 sets out guidelines and procedures to ensure that the correct quality and quantity of bunkers are being delivered safely and efficiently.

Course Objectives

- ❖ Provides advanced knowledge and skills in the application of SS600:2014, SS524:2014 and TR48:2015 in their workplace
- ❖ Raise professionalism of the industry and improve workforce competitiveness and employability
- ❖ Skill up the workforce with industry-recognised formal qualifications
- ❖ Create training avenues for workers to advance in their job career and upgrading
- ❖ Enhance workers prospect for career advancement in the bunker industry through structured progression programme and pathways

Course Entry Requirements

- ❖ At least 21 years of age and medically fit
 - ❖ Have a working knowledge of the English Language
 - ❖ Have attended the 2 days Basic Course on SS600:2014
 - ❖ Have completed at least 30 bunker deliveries as a cargo officer trainee
- *Ex-licensed bunker surveyors would be considered for exemption from the 30 bunker deliveries provided that his last surveying job was carried out in less than 12 months ago.
- **Existing cargo officers have to provide confirmation letter of their service from their company.
