Background

SPRING Singapore and the Maritime and Port Authority of Singapore (MPA) have implemented the Singapore Standard SS600:2014 & TR48:2015 to further enhance consistency in practices in the delivery of bunkers for ships calling at Singapore's port. SS600:2014 & TR48:2015 sets out guidelines and procedures to ensure that the correct quality and quantity of bunkers are being delivered safely and efficiently.
